# Portland Christian School Reduced Lunch Program

2019-20 School Year

Portland Christian School offers a reduced lunch price for households with low income. A household includes anyone living in that home that earns an income, whether it is a grandparent, parent or children with income. Households that qualify will receive lunch at the reduced price of \$2.00 per lunch for each child, with the exception of the Chick Fil A lunch. Due to price increases from Chick Fil A, in order to continue to offer it, we will require that all lunches pay the regular price for this meal, which will be \$4.50 this school year. However, students may choose the other options that day at the reduced price of \$2.00. To see if your household is eligible please refer to the income chart below.

**\*REPORTING CHANGE:** Please complete another application giving up-to-date income information if your household size decreases or your income increases more than \$50.00 per month or \$600.00 per year.

**\*REAPPLICATION:** You may apply for reduced lunch at any time during the school year. If you are not eligible now but have a change, such as decrease in household income, an increase in household size, or become unemployed, fill out an application at that time.
