**Portland Christian Reduced Lunch Program 2022-2023**

Portland Christian School offers a reduced lunch price for qualifying households with low income. A household includes anyone living in that home that earns an income, whether it is a grandparent, parent, or children with income. Households that qualify will receive lunch at the reduced price of \$2.00 per lunch, per child. The exception to this would be Chick fil-a and Café Tuesday. Due to the price increases from Chick fil-a, and in an effort to provide this, we will require that all lunches pay the regular price for that meal. However, students may choose the other option for that day at the reduced price of \$2.00. To see if your household qualifies, please refer to the income chart included.

To receive reduced lunch prices for your child, carefully complete the application and return to school. The application must include the following:

1. The student’s name and grade;
2. All household members and current amount of monthly, weekly, or yearly income and where that money comes from (see list below for details);
3. Signature of the household member who is applying; and
4. Verification of income (check stub, divorce agreement, letter from employer, etc.)\*\***Application will be denied if verification is not provided.\*\***

**Notification:** You will be notified by email when your application is approved or denied.

**Report Change:** Please complete another application giving up-to-date income information if your household size decreases or your income increases more than \$50.00 per month, or \$600.00 per year.

**Reapplication:** You may apply for reduced lunch at any time during the school year. If you are not eligible now but have a change, such as a decrease in household income, an increase in household size, or become unemployed, fill out an application at that time.
